Ladies/Gentlemen:

**Bids Must be Submitted to Hampton Procurement Office at 1 Franklin Street, Ste 345, Hampton VA 23669. Bids will be accepted in person or by mail. All bids must be received prior to 10:01 a.m. The bid should include one original signed copy and a flash drive of your complete proposal. No bids can be emailed or faxed- These will not be accepted.**

**Addendum #1 is being issued to respond to questions received.**

1. Question: Page Number 7 and 55 – Minimum eligibility requirements and Attachment E: Bid Bond. Is the required bid bond 10% or 5%?  
Answer: The required bid bond is 5%.
2. Question: Page 21 Proposal Requirements General Requirements. How does HCS want us to submit the proposal and where? Please Clarify the submission method.  
Answer: Please see the submittal instructions above.
3. Question: I cannot find a place in the RFP where it tells offerors how to submit proposals: is it electronically only to you? Is it hard copy to you?  
Answer: Please see submittal information above.
4. Question: If hard copy, how many copies are required? Is it both hard copy, and electronic copy?  
Answer: One original signed copy and one complete copy on a flash drive.
5. Question: Can you please provide the full service addresses for each remote location and the hub site that will be included in the WAN. Also, please indicate the bandwidth needed at each location.  
Answer: This is covered in the RFP. See Appendix E which lists addresses. As stated in the RFP, we would like pricing for 1 GB to 40GB in intervals of 1GB.



**ADDITIONAL TERMS AND CONDITIONS FOR  
FEDERALLY-FUNDED TRANSACTIONS**

The purchase of goods or services funded in whole or in part by the Federal Government are subject to the requirements of 2 C.F.R. §§ 200.317 – 200.326 and 2. C.F.R. Part 200, Appendix II. In all federally-funded transactions, the contractor, vendor, or supplier (“Contractor”) is responsible for ensuring its compliance with all applicable Federal requirements. - A. The contract is a covered transaction for purposes of 2 C.F.R. pt. 180 and 2 C.F.R. pt. 3000. As such, contractor is required to verify that neither the Contractor, nor its principals (defined at 2 C.F.R. § 180.995), or its affiliates (defined at 2 C.F.R. § 180.905) are excluded (defined at 2 C.F.R. § 180.940) or disqualified (defined at 2 C.F.R. § 180.935).

- A. Contractors who apply or bid for an award of \$100,000 or more shall file the required certification. - A. Overtime requirements. No contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers or mechanics shall require or permit any such laborer or mechanic in any workweek in which he or she is employed on such work to work in excess of forty hours in such workweek unless such laborer or mechanic receives compensation at a rate not less than one and one-half times the basic rate of pay for all hours worked in excess of forty hours in such workweek.
- B. Violation; liability for unpaid wages; liquidated damages. In the event of any violation of the clause set forth in paragraph (b)(1) of this section the contractor and any subcontractor responsible therefor shall be liable for the unpaid wages. In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages. - C. Withholding for unpaid wages and liquidated damages. The City shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (b)(2) of this section.
